Consider for approval, and authorize the CSB General Manager, or his designee, to effect the award of a purchase contract to Stephens Auto Center, of Danville, WV, the only responsible bidder, for a Ford F-550 truck chassis cab, in the amount of \$38,324.00. This truck chassis cab replaces CSB Pump Department's unit 94 (2008 model). CSB FYE20 capital budget for this item is \$42,000.00.

service body and crane replaces CSB Pump Department's unit 94 (2008 model). CSB FYE20 capital budget for this item is \$54,000.00.

- D. Consider for approval, and authorize the CSB General Manager, or his designee, to effect the award of a purchase contract to Stephens Auto Center of Danville, WV, the only responsible bidder, for a Ford F-250 extended cab, 4x4 pick-up truck, in the amount of \$29,997.00. This extended cab pick-up truck replaces CSB Maintenance Department's unit 100 (2008 model). CSB FYE20 capital budget for this item is \$40,000.00.
 - E. Consider for approval, and authorize the CSB General Manager, or his designee, to take all actions necessary to effect Change Order No. 1, to Tribute Contracting and Consultants, Inc. Contract 18-3A Phase 1 in the amount of <\$387,688.00>, thus revising the current contract amount from \$5,144,375.00 to \$4,756,687.00 and no increase in the Contract Time. The decrease in contract cost associated with this change order is due to the work removed across five parcels of property where CSB has not acquired an executed right of entry order or executed sanitary sewer easement.
